Chrissy also reported that she has someone who will provide free, carpenter project labor.

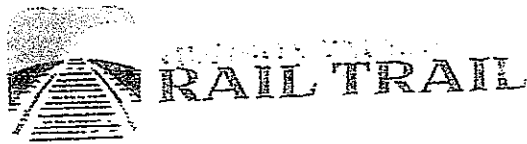

Jennifer is now starting the mural of the town of Centerville and the mural of the Centerville Hotel. Pattie requested that our committee approve \$5000 to Jennifer Keltos to complete two more murals. These murals will be of the "Rock House" that is located in the Illinois Mountain and the other mural will be of the stone house located on Weed's Mill road that was built in 1810. Motion was made by Chrissy to pay Jennifer Keltos \$5000 to complete the "Rock House" and the 1810 stone house. Secondary motion made by Rahael. Motion approved.
